

Cookie policy

What are cookies?

When a visitor visits this website, a small data file called a cookie (hereinafter referred to as a cookie) is placed on the visitor's computer. A cookie is a technology necessary for the operation of online services that provides an efficient visitor experience and is supported by browsers. Some of the cookies used on this website are temporary and disappear when the browser is closed, while there are convenience cookies that are stored in a file on the user's computer for a limited period. This ensures that on return visits the computer's browser remembers the settings used previously, so that it is not necessary to accept the cookie policy again or to regularly readjust user settings. The cookie is stored in a file, the contents of which can be retrieved from the browser at any time by the web server sending the cookie.

Types of cookies used on the site according to their lifetime

Session cookies

This type of cookie is stored temporarily on the visitor's device, only for the current session and are deleted automatically when the session ends or the browser is closed.

Permanent cookies

Permanent cookies are files that are stored on the visitor's device until they are manually deleted or are automatically deleted after a set period of time.

Purpose of cookies used on the site

Essential cookies

These cookies are essential for navigating the website, for the use of key functions of the website and to access protected content. These cookies do not collect information that could be used for marketing purposes or to remember other websites the visitor has visited. Without these cookies, the website or parts of the website may not be displayed or may be displayed incorrectly, making it impossible to use the page or fill in forms. For this reason, these cookies may be lawfully used without the consent of the data subject.

Cookie settings

Widely used browsers allow you to change the way cookies are handled. Users can disable, allow or delete cookies on their computer. You can also delete cookies from your hard disk before they expire. The cookie settings can be changed at any time, even several times.

It is important to stress that limiting or deleting cookies can enhance the protection of personal data, but these operations significantly affect the usability of the website and the functioning of certain functions. Information on how to enable or disable cookies is available at the links below:
